Issue of Options

Cobalt Blue Holdings Limited (ASX:COB or the Company) advises that it has today issued a total of 2,698,250 options to seven of its contractors under the Company's Employee Option Plan (EOP) and to Blue Ocean Equities Pty Ltd (BOE) as part of the remuneration for its corporate advisory role.

The 698,250 options issued to the Company's contractors have a \$0.30 exercise price and will expire, if not exercised, on 21 December 2021. They will vest as to 50% on 21 December 2019 and 50% on 21 December 2020.

The 2,000,000 options issued to BOE have a \$0.30 exercise price and will expire, if not exercised, three years from the issue date i.e. 26 June 2022. They have been issued to BOE as part of the remuneration for its corporate advisory role to be carried out over the coming three years, or as agreed between the parties.

Attached is an Appendix 3B for the issue of these options.


